- Early January Thoughtexchange consultation was mailed to all Sherwood Park Elk Island Catholic School parents and a link was made available on the Division's website;
- Early February (February 6) results of the Thoughtexchange and possible options will be shared with participants in coffee-house meetings;
- Mid-February is the deadline for feedback on the options presented;
- Early March preferred options are brought back to the community;
- March 21 EICS' Board of Trustees vote on the recommended option.

A Board discussion ensued about the most preferred options with an agreement to select those options which meet the Division's framework of being financially obtainable, aligned with Alberta Education standards, and sustainable into the future.
