III. CONTEXTUAL INFORMATION

The Elk Island Catholic Separate Regional Division No. 41 was formed on February 1, 1998 serving the Catholic communities of Camrose, Fort Saskatchewan and Sherwood Park. In May, 2001 by virtue of a Ministerial Order, the Catholic schools operating in the community of Vegreville were added to the School Division. There are fifteen schools in the Division: two in Camrose, three in Fort Saskatchewan, two in Vegreville, and eight in Sherwood Park. The Mission, Vision and Belief Statements reflect an emphasis on the spiritual and moral development of students as well as on their intellectual, social and physical developments. The statements also include a belief in life-long learning for all members of the communities.

The total enrolment of students as of September 30, 2001 was 5608.5 full time equivalent (FTE) students. There were 432.0 FTE students in Camrose, 884.5 FTE students in Fort Saskatchewan, 629.0 FTE students in Vegreville, and 3663.0 FTE students in Sherwood Park. There were 219.5 FTE kindergarten students, 1432 primary students, 1494 upper elementary students, 1364 junior high students, and 1099.0 senior high students.

In addition to providing a full range of core programs to its students, the Division schools provided a broad range of complementary subjects along with numerous co-curricular and extracurricular activities. The Division also offered instruction in French Immersion and Ukrainian Bilingual programs. Students with special needs were taught within the Division in a full spectrum of programs.

In the five-year interval from 1996 to 2001, the Division schools have experienced an 18.1% increase in enrolments.

IV. KEY ACCOMPLISHMENTS

Many significant accomplishments were achieved during the course of the 2001-2002 school year. The following are but a few of the more important events and activities.

- Continuation of the transition to include the Vegreville Catholic Schools and community into the School Division.
- Continuing work on the building of a new Multi-Campus Learning Facility (K-9 school) to serve the needs of the Sherwood Park ward

- On-going work with the Catholic parents and community of Camrose to establish a Catholic High school program beginning in September, 2003.
- Significant work and accomplishments in all four (4) areas encompassing the Division's AISI projects (Alberta Initiative for School Improvement), namely; Improvement of Kindergarten Program; Student Centre John Paul II High School; ICT Program of Studies Implementation; and, Literacy for Learning; and, implementation of a new, fifth project, namely a Student Centre at St. Mary's High School in Vegreville.
- Implementation of curriculum changes as mandated by Alberta Learning, and related professional development opportunities for staff members.
- A number of initiatives related to Information Technology including the following: the implementation of a Technology Equity Plan to address some of the hardware inequities existing amongst and between Division schools; the creation of hardware and software standards; increasing students' access to computers in all schools; improving the Division's networks and email system; and, improving student reporting with the use of technology.
- Completion of a major \$1.9 million modernization project at St. Mary's High School in Vegreville.
- The development of a program to encourage international students to attend Elk Island Catholic schools
- The completion of a Communications Audit for the School Division, resulting in the establishment of a working committee that was tasked to develop a Communications Plan to present to the Board of Trustees by December, 2002.
- The completion of a two-year Leadership Program designed to encourage and develop staff members aspiring to future administrative positions within the School Division

- The extension of a partnership with our public School Division neighbour and industry to expand a "hands-on, minds-on" Science program into the Junior High grade levels.
- The offering of a Mentorship Program aimed at coaching and supporting new teachers in their initiation to the teaching profession and their career.
- Using an inclusive model of education, multiple supports, programs, and resources aimed at meeting the unique needs of students requiring special education services.

Provincial Goal 1:

High quality learning opportunities will be made available to all students.

Desired Results

- The Division is responsive, thus meeting the needs of all learners and the community.
- The Division is flexible and provides a variety of programs and modes of delivery.
- The Division is accessible to the extent that all students can participate in learning.
- Financial need is not a barrier to students participating in learning opportunities.
- Education is affordable within the Division.
- Schools will implement curriculum changes as indicated by Alberta Learning.

Measures for Goal One

- 79% of parents are satisfied with the opportunity to select the school or program of their choice.
- 92% of students in Grades 4 and 6, 90% of students in Grades 8, 10 and 12, 91% of parents, and 95% of teachers are satisfied that schools are safe environments.
- 89% of students in Grades 8, 10 and 12 say that they pray regularly in school.
- 95% of parents are satisfied that religious faith is a part of all aspects of school life.
- 85% of parents are satisfied with the opportunities for involvement in decisions that affect education in their children's schools
- 93% of teachers believe that the educational standards in the schools are high.

Provincial Goal 2:

Excellence in learner achievement will be a priority throughout the School Division.

Desired Results

- Students will demonstrate high standards.
- Students' completion rates of a number of programs will be increased.
- Catholic learning environments that are comprehensive, creative,

- Teachers' professional growth will focus on the knowledge, skills, and attributes required to meet the diverse needs of all students.
- Division staff are models of faith commitment and of faith practice.

Measures for Goal Two

- 90% of parents are satisfied with the quality of education their children are receiving.
- 85% of students in Grades 4 and 6, 87% of students in Grades 8, 10 and 12, and 90% of parents are satisfied with their school or their children's school overall.
- 87% of students in Grades 4 and 6, and 81% of students in Grades 8, 10 and 12 are satisfied with the variety of learning activities in the classroom.
- 94% of students in Grades 4 and 6, and 80% of students in Grades 8, 10 and 12 are satisfied with their skills to use computer technology.
- 98% of teachers believe that students are learning what they need to know.

Provincial Goal 3:

Student will be well prepared for lifelong learning, the world of work, and citizenship.

Desired Results

- Children will start school ready to learn.
- Students are provided with opportunities to learn continuously in school and at home.
- Students are well prepared for work.
- Students are well prepared for citizenship.
- The Division will continue to implement an inclusive education policy.
- The Division will continue to implement comprehensive school Guidance and Counselling Programs in all schools.

Measures for Goal Three

- 90% of students in Grades 8, 10 and 12, and 95% of parents are satisfied that they or their children are learning to be concerned, responsible citizens.
- 84% of students in Grades 8, 10 and 12, and 71% of parents are satisfied with how they or their children are being prepared for entry into the workplace or for further study.
- 82% of parents are satisfied with the opportunities they have been given to meet and share information with the school's Special Needs Team.
- 88% of parents are satisfied that their child's teachers are aware of their child's special learning, emotional and/or behavioral needs.
- 79% of parents are satisfied with the access to community-based programs and services to meet the special needs of their children and family.

Provincial Goal 4:

The Division and its schools will endeavor to establish and promote effective working relationships with partners.

Desired Results

- Effective community partnerships, including those related to the parishes and businesses, will meet the learning needs of students.
- Joint initiatives will contribute to the social and economic goals of the province.

Measures for Goal Four

- 84% of students in Grades 8, 10 and 12, and 71% of parents believe that they or their children are well prepared to be skilled, productive members of society.
- 90% of parents are satisfied with the quality of their children's education.

Provincial Goal 5:

The education system is open and accountable for the achievement of results and the use of resources.

Desired

Assertive leadership will be provided in the Division's communities and churches and with government as advocates for the rights of Catholic education in the province.

- Effective two-way communication will occur with all of the Division's stakeholders.
- The Division will be fiscally responsible.
- Parents and the community will have timely and meaningful information about education, including student achievement and expenditures from the School Board and its schools.
- The Division and its schools will systematically use performance measure results to make continuous improvements to education.
- Schools will involve parents and community agencies in formulating and reviewing Individual Program Plans for special needs students.
- The Division's schools will be welcoming, pleasant environments for learning, and they will be efficiently operated.
- 93% of parents are satisfied with their access to information from their children's school about their children's educational progress and achievement.

Measures for Goal Five

- 88% of parents are satisfied with the quality of information they receive from their children's school about their children's educational progress and achievement.
- 93% of parents are satisfied with the information provided about the School Division and its operation.
- 75% of students in Grades 4 and 6, 80% of students in Grades 8, 10 and 12, and 93% of parents are satisfied with their school's environment, cleanliness, and efficiency.

VI. CAPITAL PLAN

The 2001-2002 year was an extremely busy one for the School Division's Facilities Department, its staff complement, and school-based custodial staff. In addition to the major modernization project at St. Mary's High School referenced previously in this report, every school in the Division was the benefactor of some monies to attend to capital projects to improve the physical plant(s).
