EICS Board Approves 2020-2021 Budget

At the May 27, 2020 public meeting, the Elk Island Catholic Schools (EICS) Board of Trustees approved the Division's operating budget for the 2020–2021 school year.

EICS' total operating budget for the year is \$79.8 million with revenues being projected as \$79.7 million. This leaves an overall deficit of \$90,133 at the end of the 2020-2021 school year. The budget continues to align resources with the Division's priorities to meet the student needs in our communities.

Highlights of the divisional budget for 2020-2021 include:

- EICS provides educational services to over 7,900 students in its communities
- Increase of 80 full time equivalent students over 2019-2020

Class sizes are projected to increase in 2020-2021, Overall estimates are as follows:
