### **Engagement on Cambrian Area Structure Plan**

At the June 16<sup>th</sup>, 2021 public board meeting, the Board moved that the Superintendent develop a communication plan to inform the community of the ramifications of the Cambrian Area Structure Plan.

In August, a Thought Exchange was launched for parents/stakeholders to share their thoughts and suggestions on what the Elk Island Catholic School Board should be advocating for as it relates to the proposed school sites in the Cambrian Area Structure Plan.

207 people participated in the exchange, sharing over 100 thoughts on the proposed school sites. The collective response from participants was support for 2 school sites as originally proposed, allowing each site space for sport fields, outdoor activities, growth, and ample parking which in turn would help reduce traffic flow and keep students safe.

Further feedback indicated 80% of respondents showed support for two school sites of 10 hectares over one shared school site of 6.1 hectares.

The EICS Board of Trustees moved to accept the engagement data and will use this feedback to advocate with Strathcona County in future meetings.
