SCHOOL FEES AND CHARGES

Under Section 57, the Education Act allows for the Board to charge fees to Parents/Guardians provided:

- 1. They are used for the purpose for which they were collected;
- 2. They are the types of fees that are allowable under the School Fees Regulation.

Definitions

Basic Educational Services

The services, supports and materials required for a student to meet the core curricular outcomes at a basic level as defined in the Guide to Education. (Math, Science, Language Arts, Social Studies, Religion, Physical Education, Health, Art, Music) Examples of the basic level of service include in-class instruction and supports, handouts, textbooks, mandatory workbooks, paid electronic educational content and photocopying.

Enhanced Educational Services

Services and materials that are not required to meet the core curricular outcomes at a basic level as defined in the Guide to Education but that are provided to enhance the student's learning opportunities. Examples include curricular field trips, programs of choice, cultural activities, one to one student technology and options programming.

Non-curricular Services

Optional activities or materials outside of the educational mandate of the Division. Examples include non-curricular events, sports teams, clubs, agendas, lunch hour supervision, lockers, parking, extended non-curricular trips and other mandatory non-curricular materials.

The Board shall approve the Division Fee Schedule during the Spring budgeting process that sets what fees may be charged and what maximums may be charged by grade level for each fee.

Within the limits set by the fee schedule, the Board authorizes the Superintendent to set and collect school fees or sub-delegate this authority, provided the following principles are followed:

Principles

1. Schools will consult with parents/guardians through their school council and school-wide communication prior to setting, increasing or decreasing school fees.

2. No parent/guardian shall pay a fee that is prohibited under the School Fees Regulation

or that is for Basic Educational Services.

3. Parents/guardians shall be provided the opportunity to have their students receive Basic

Education Services at no cost.

4. Fees are to be charged on a cost recovery basis and are to benefit the student of the

parents/quardians who paid the fees.

5. The Division will support a transparent fee waiver procedure where the criteria and

procedure for fee waivers are posted on the Division's website. The public shall be reminded annually of the fee waiver procedure.

6. The Division will refund unspent fees on a prorated basis for students who leave the

Division prior to the end of the school year. Other Division fees will be refunded based on

individual project plans.

7. A student's educational experience shall not be impacted by non-payment by

parents/guardians. Only services related to programs of choice or non-curricular services may be denied to students as a result of non-payment of fees.

8. Parent/guardian disputes on fees shall be subject to appeal to the Secretary-Treasurer.
