Living the Gospel: charity as a calling in Catholic education

This month's Faith Formation with our Elk Island Catholic Schools (EICS) Board of Trustees at their regular public meeting explored the theme of charity and our calling to meet the needs of students beyond providing an education.

The Trustees were blessed to have Darby Murphy, the Principal at St. Martin's Catholic School and a member of the EICS Faith Formation team, lead the discussion.

For his presentation to the Board, Murphy focused on how the act of charity ties into the history of the Catholic church and connects directly to the work done in our schools today.

Pointing to Matthew 25:37-40, the parable of the sheep and goats, Murphy said Jesus makes it clear that a life worthy

of Heaven must be one in service to helping others in need. He noted that the first hospital in the Roman Empire, built around the year 400, was motivated in part by the teachings of Jesus Christ, emphasizing love, compassion, and care for the sick and needy.

In fact, "Monasteries and religious orders often provided refuge for travelers, pilgrims, and the sick, contributing to the development of early hospital systems that later evolved into more structured healthcare institutions," Murphy noted.

Within the context of EICS, this act of charity prioritizes the holistic wellbeing of each student and staff member. This emphasis on addressing physical, spiritual, and psychological wellness of students and staff is one of the four key pillars that form our division's annual assurance strategy.

Murphy said school staff respond to this calling through meeting the needs of students through acts of charity that extend well beyond the traditional role of being an educator.

"Christian charity is at the forefront of Catholic education," Murphy said. "It'snotjustaboutteaching, but it's about spreading the Gospel; God's love.... It is a lifestyle, it is a calling for teachers, for sure."

Focused on recruitment, faith leadership, wellbeing

#### **HUMAN RESOURCES**

Brett Cox, the EICS Assistant Superintendent for Human Resources, presented an update on his department's activities for the current school year.

A top priority for the fiveperson team this year was an overhaul of the careers page on the EICS website with the goal of improving overall staff recruitment and retention.

The team is also actively seeking other ways to refine recruitment through partnerships with postsecondary colleges for practicum students, while demonstrating our Catholic faith when attending recruitment events.

For existing staff, HR has focused on strengthening internal mentorship programs, continuing to refine work flow and communication between the schools and other EICS departments, making documents more widely available that detail common HR processes, and intentional visits to schools throughout the year.

Coxsaid the goal of every HR effort is to strengthen the education EICS provides to all students.

#### **CATHOLIC SCHOOL REVIEW**

Archbishop Jordan Catholic High School (ABJ) recently completed its Catholic School review. These reviews are conducted by division administration to assist schools in identifying strengths and areas of improvement regarding its delivery of education and Catholic identity.

The ABJ review affirms the school's strong Catholic identity and Christ-centred community, commending faith formation initiatives that engage staff and Connecting students with their local parish priests is a key part of the EICS faith mission.

Next steps for ABJ include deepening Catholic integration across all subject areas, expanding opportunities for prayer, and enhancing faith leadership through professional development.

### **BISHOP ASSURANCE UPDATE**

Our role as a pilot group in the Catholic Bishops of Alberta and the Northwest Territories'Bishop Assurance Project is ongoing.

We continue to work closely with Archbishop Richard Smith on this project, however he was recently appointed to the Archdiocese of Vancouver by Pope Francis.

Currently, Archbishop Smith is serving as the Administrator of the Archdiocese of Edmonton until his formal installation in Vancouver later this spring.

We are eternally thankful for His Grace's ongoing vision, leadership, and dedication to Catholic education and the Catholic faith, and we pray that he receives abundant blessings and continued strength as he begins this new chapter of service and leadership in Vancouver.

### LURANA SHELTER DONATION

The EICS community has donated more than \$40,000 in support of Lurana Shelter during this school year.

Most of the money was donated during the Advent season leading into Christmas, however \$3,000 was collected during Mass at our division's Faith and Wellness day on March 7.

Currently, EICS has a Lenten donation drive collecting clothing and stuffed animals in support of the first-stage emergency shelter for women and their children.



St. Patrick's Day was a celebration of all things Irish and green across all EICS schools. It also offered an opportunity for students and staff to reflect on how we can better serve others, not unlike St. Patrick.

**Updated 3-Year Capital Plan refines board priorities** 

At its March 19 public meeting, the EICS Board of Trustees approved 2026-2029 the 3-Year Capital Plan and the 2025-2034 10-Year Facility Plan, which outline the division's priorities for school construction. modernization, and longterm planning.

These plans are updated annually to reflect the division's evolving needs and to present compelling funding requests to Alberta Education for future capital projects.

### PRIORITY 1: K-4 SCHOOL IN FORT SASKATCHEWAN

The top priority in the updated capital plan is to seek \$25.1 million in funding for the design and construction of a new 540core capacity Kindergarten Grade 4 school in to Fort Saskatchewan. This funding would result in the consolidation of Our Lady of the Angels (OLA) and St. John XXIII Catholic schools and also include the demolition of OLA once the new school is operational.

The City of Fort Saskatchewan has designated land in the Forest Ridge community for the location of the new school.

build request follows the value scoping and public engagement that was held with our school communities in Fort Saskatchewan in the first half of 2024. For more on that, see our <u>Planning</u> for the Future in Fort Saskatchewan web page.

Presenting the capital plan to the Board, Secretary Treasurer Tracy Leigh explained that funds are not being requested to demolish the St. John XXIII building as it offers valuable surplus for the division once the new school is operational.

Since no provincial funding has been acquired for the design and build phases, there are no timelines for this project at this time.

### PRIORITY 2: PRE-PLANNING FOR SHERWOOD PARK

The second priority

seeks \$120,000 to conduct value scoping and public engagement in Sherwood Park. The goal is to explore options for increasing school utilization rates and enhancing learning environments.

The value scoping would include a cost/ benefit analysis of the longterm maintenance cost of keeping underutilized sites running versus the cost of operating a new, more efficient consolidated school.

Leigh told the Board that this priority was amended from а year ago to remove language suggests potential that consolidation of elementary schools to leave the options more open ended due in part to year over year enrolment changes.

"In looking at Strathcona County as a whole and what a value scoping session would entail, we can't say for sure (consolidating two Kindergarten to Grade 4 schools) is what would come out of the value scoping," she told the "We didn't Board. feel comfortable. SO we're asking for pre-planning funds to do some public engagement to see what we can come up with for a solution to increase the utilization rate."

EICS Superintendent Paul Corrigan told the Board that capital planning involves aiming for goal posts that can shift from year to year. "This is primarily because of the good work being done in our schools and the new programs being offered," he said.

A similar request in 2024 was not funded, but EICS administration is committed to securing the necessary resources. If funding is received, public engagement sessions are not planned to begin prior to 2026.

### PRIORITY 3: RIGHT-SIZING STUDY FOR VEGREVILLE SCHOOLS

Mary's Catholic School or St. Martin's Catholic School.

would involve This a value scoping study and public engagement to assess a cost/benefit analysis of the longterm maintenance cost of keeping underutilized schools running versus the cost of consolidating and modernizing either school. Pending the results of the value scoping workshop and public engagement, EICS will develop a more detailed scope of work and cost estimate.

The 3-Year Capital Plan is requesting funds to hold value scoping and public engagement sessions as well as planning and design funding to help develop one of two options:

- Option 1:\$10.8 million in funding to consolidate both schools into St. Mary's.
- Option 2: \$14.2 million to consolidate both schools into St. Martin's.

Similar to other projects, no timelines have been set as the initiative depends on provincial funding.

### LONG-TERM PLANNING & FUTURE GROWTH

The Board also reviewed as part of this document a long-range 10-year facility plan for 2025-2034, which guides EICS in providing high-quality learning spaces close to home.

New residential developments in Cambrian and Bremner near Sherwood Park have been identified as potential sites for future Catholic schools, while other communities may see shifting enrolment trends based on local growth.

### ONGOING ADVOCACY FOR FUNDING

While EICS was not included in the province's 2025 capital funding announcements, Leigh noted that funding could still be granted at other points in the year.

"The most important thing is showing that the division has a solid plan moving forward," she said. "We have a direction, and we know what we're asking for."

Our EICS Board of Trustees held their monthly public meeting in Vegreville on March 19, and then had the opportunity to meet with Vegreville Town Council. The group shared a meaningful conversation about how our division and the Town can work together.

2026-2027 calendar approved for most communities

With their approval on Wednesday, March 19, the EICS Board of Trustees took a historic step — approving a school year calendar more than a year in advance for the first time in our division's history.

The 2026-2027 school year calendar applies to schools in Fort Saskatchewan, Sherwood Park, Strathcona County, and Vegreville. Schools in Camrose are not included at this time.

Superintendent Paul Corrigan shared that the early approval was directly influencedbyparentfeedback received during consultations for the 2025-2026 calendar. Families expressed a preference for having school calendars available sooner, and with our student transportation provider in these communities already releasing their schedule, the division was able to move forward.

Corrigan also addressed questions from the Board about the last day of school falling on Monday, June 28, 2027. He explained that this is due to Alberta Education scheduling the Science 30 diploma exam on that date, a decision affecting school divisions across the province. If that exam date changes, EICS Trustees and administration will have the opportunity to review and consider amending the calendar.

The 2026-2027 calendars for Camrose schools have not yet been proposed, as the student transit provider for EICS students in that community has not finalized its schedule. These calendars are expected to be approved in early 2026.

In Fort Saskatchewan, Sherwood Park, Strathcona County, and Vegreville, notable dates for the 2026-2027 school year include:

- Aug. 31, 2026: First day of school
- Nov. 9 13, 2026: Fall break
- Dec. 21, 2026 Jan. 1, 2027: Christmas break
- March 22 26, 2027: Spring break
- March 26, 2027: Good Friday
- March 29, 2027: Easter Monday
- June 28, 2027: Last day of school
