Reflections on Lazarus and Compassionate Leadership

During April's Elk Island Catholic Schools (EICS) Board of Trustees meeting, the Trustees were invited to reflect on the raising of Lazarus in John 11.

This moment in the Gospel reveals Jesus not only as the one who brings life, but as someone who fully enters into our humanity.

"Jesus wept. Not because He lacked hope, but because He loved," explained Jody Seymour, who led this reflection during her final week serving as the director of Student and Staff Formation for EICS. "Grief is not a lack of faith. Tears are not weakness."

In their role as leaders in theCatholiccommunity, EICS Trustees may be expected to keep their emotions level. However, Seymour noted that this recounting of Lazarus' resurrection is a reminder that some of our most Christ-like moments

are experiencing pain and occur when compassion is offered to those who suffering.

In John's Gospel, Jesus doesn't rush to heal the suffering of Lazarus' sisters Mary and Martha. He stops, weeps, and walks alongside the two siblings before ultimately returning their brother Lazarus to life.

The message of this story carries through today, Seymour said. "He doesn't avoid death, He transforms it. And He still does that today for us, and through us."

Trustees were encouraged to reflect on how this Gospel story speaks to their own leadership and their call to lead with compassion. They were also asked to reflect on how this story sets the stage for the rest of John's Gospel notably the coming passion, death, and resurrection of Christ.

To be rooted in Christ, Seymour said, is to be rooted in resurrected life, in mercy, and, ultimately, in hope.

Board Highlights

Preparing for 2025–2026: finances and planning

PROJECTED FUNDING FOR 2025-2026

Our division is projected to receive \$77 million in total funding from Alberta Education for the upcoming school year, an increase of \$2.8 million compared to the current school year due to increased student enrolment.

Of that funding, \$75.8 million is anticipated to go to operational costs, while \$1.1 million will be dedicated to Capital Maintenance Renewal.

A final budget will be presented to the EICS Board of Trustees for approval at the May public Board meeting.

2025-2026 FEES SET

The division fees and the maximum fees that could be charged by schools were reviewed and updated for next school year by the Trustees at the April Board meeting.

Student Transportation fees for buses operated by EICS will be reduced for students next school year. This includes all students in the Eligible and Ineligible fee categories who ride EICS-operated buses. The supplemental fee for students to access an additional EICSoperated bus to/from an alternate address remains unchanged, however.

Other changes were made to align fees charged for identical programs at different schools or to cover the cost of necessary materials. Revisions were also made to the Unfunded Kindergarten programs, now called Early Childhood Services (ECS) Supplemental Programs.

NUTRITION FUNDING

EICS has received \$255,288 in funding for the 2025-2026 school year to support student nutrition. This funding will support long-standing programs at five specific schools while providing additional funds across all other schools to promote universal access to healthy food. The funding may be used for snack programs, healthy food sampling, wellness initiatives, and to support families in need throughout the year.

VTRA AGREEMENT WITH BATTLE RIVER SCHOOL DIVISION

An updated Violence Threat Risk Assessment (VTRA) Protocol was signed by our division alongside partners from Battle River School Division, Alberta Health Services, and the RCMP.

This reaffirmed agreement strengthens the collaborative approach to early intervention and supports the ongoing commitment to student safety,

well-being, and coordinated community response.

CAMROSE SCHOOL BUS UPDATE

Following the April announcement that the current Camrose student transportation provider will discontinue its services at the conclusion of the current school year, our Student Transportation department has been hard at work developing a plan to offer student busing in Camrose for the 2025-2026 school year.

EXCEL PARTNERSHIP

Our division will once again partner with four Catholic school divisions and Newman Theological College in the ExCEL program, a Catholic leadership formation opportunity for teachers.

ONGOING EDUCATION Assurance Planning for 2025-2026

By the end of April, all schools and division departments will have presented their Assurance plan findings and strategies to EICS Senior Administration.

These presentations review results from the 2024–2025 EICS Education Assurance Survey and discuss strategies for the upcoming school year.

The finalized 2025–2026 EICS Education Assurance Plan is expected to be presented for ratification at the May public Board meeting.

BUSINESS SERVICES PRESENTATION

Heather Whyte, the Director of our Business Services, updated the Board on initiatives her department has undertaken this school year to enhance services for division staff and families while reducing costs.

Since the division switched to utilizing Amazon Business Prime, the division has realized cost savings and more efficient processes.

She also highlighted increased efforts to raise awareness of the division's fee-waiver program and to visit school offices to share best practices while verifying internal controls.

Recapping the department's assurance results, she noted that it scored 98% and higher in each of the four questions that pertain to Business Services.

Looking to next school year, Business Services plans to upgrade payment systems, build on its collaboration with schools, and create new onboarding guides for staff.

PASSING OF POPE FRANCIS

During the April Administration meeting, school and division leadership paused to reflect on the life and legacy of Pope Francis following his death on Easter Monday, April 21.

Superintendent Paul Corrigan encouraged principals to be mindful of the diverse ways staff and students may be affected by this loss, offering support and prayerful reflection during this time of mourning.
